简介 | The Introduction



第十八届世界海南乡团联谊大会简介

世界海南乡团联谊会（The World Federation of Hainanese Associations）是全球海南乡团的民间联谊组织，在1989年成立。其宗旨在于加强全球海南乡团的联系与友好合作，促进世界各地海南乡亲的团结互助，推动民间文化、体育、学术及商贸领域的深度交流，并凝聚海南乡团与乡亲的力量，共同推动经济、文化与教育的发展，提升海南籍人士的全球影响力与社会地位。世界海南乡团联谊会设立理事会作为执行决策机构，现有来自16个国家和地区的18个海南乡团担任理事成员，其中包括马来西亚海南会馆联合会。

世界海南乡团联谊大会概述

世界海南乡团联谊大会（Congress of World Federation of Hainanese Associations），每两年由各理事乡团轮流主办。自1989年首届大会在新加坡成功召开以来，已先后在新加坡、泰国、海南、香港、澳门、马来西亚、美国、文莱、印尼、澳大利亚等十个国家和地区举办了17届大会，汇聚全球海南乡团和海南籍精英，共同探讨海南乡亲的发展机遇。

马来西亚首次主办世界海南乡团联谊大会是在1999年，如今，时隔26年，第十八届世界海南乡团联谊大会（The 18th Congress of World Federation of Hainanese Associations 简称 HNWF2025）将于2025年11月14日至16日在马来西亚槟城隆重举行，主会场设于SETIA SPICE国际会展中心。

值得一提的是，马来西亚槟城州与中国海南省于2013年11月7日正式缔结为友好省州，为两地在经济、文化、教育及社会领域的合作交流奠定了坚实基础。

大会使命与影响

经过36年的发展，世界海南乡团联谊大会的规模与影响力不断扩大，已成为全球海南乡团和琼籍乡亲最重要的联谊交流平台，同时也是海南省与世界各地海南乡团紧密联系的重要桥梁。本届大会将在延续传统的基础上，以创新精神推动海南乡团的发展，搭建更广阔的国际合作平台，促进全球海南人资源共享、事业互助，共同开创更加辉煌的未来。

The Introduction

The World Federation of Hainanese Association, established in 1989, is a global civil fellowship organization for Hainanese associations. Its goal is to **strengthen connections and cooperation among Hainanese groups**, promote unity and mutual support, and foster cultural, academic, and business exchanges. The congress aims to enhance the global influence and social status of Hainanese people.

The congress operates through a **Council with 18 member associations from 16 countries**, including The Federation of Hainan Association Malaysia.

The Overview

Congress of World Federation of Hainanese Associations, held every two years by rotating member associations. Since its first successful meeting in Singapore in 1989, it has been hosted in 10 countries and regions, which including **Singapore, Thailand, Hainan, Hong Kong, Macau, Malaysia, U.S.A, Brunei, Indonesia, and Australia**. The event gathers global Hainanese elites to explore development opportunities.

Malaysia hosted the congress in 1999. Now, after 26 years, **The 18th World of Congress of World Federation of Hainanese Association (HNWF2025)** will be held in Penang from **November 14–16, 2025**, at the **SETIA SPICE International Convention Centre**. Notably, Penang and Hainan Province became **sister regions in November 7, 2013**, strengthening cooperation in economic, cultural, and educational areas.

Mission and Impact

Over 36 years, the congress has grown in scale and influence, becoming a **key platform for global Hainanese fellowship and a bridge for Hainan Province's ties with Hainanese groups worldwide**. This year's congress will continue traditions while driving innovation to expand international cooperation, promote resource sharing, and help create a brighter future for Hainanese people globally.

2025年第十八届世界海南乡团联谊大会徽章设计概念:

以马来西亚国花 Bunga Raya（大红花）为核心灵感，徽章设计融合民族文化精神与全球化视野。主体以五片单瓣朱槿构成，严格遵循国花形态标准，象征海南乡团“开放、团结、传承、共荣、创新”五大精神内核。

每片花瓣巧妙融入马来西亚国旗四色——蓝、黄、白、红：蓝色寓意多元包容的海南文化，黄色致敬海南人勤勉奋斗的传统，白色象征文化传承的纯粹初心，红色凝聚血脉相连的乡情纽带。而绿色寓意着生命力，中央单支金色花蕊呼应“根脉相连，生生不息”的侨胞精神。

为彰显全球海南乡亲情谊，大会特别准备23国限量版特别融入各国家的标识纪念套装。以花为媒，以色为语，将世界海南侨胞在全球足迹凝练为永恒纪念，传递“一花五瓣连四海，天涯乡情共此心”的深刻寓意。

The Design Concept of the Badge of HNWF2025:

With Malaysia's national flower, Bunga Raya (Hibiscus flower) as the core inspiration, the badge design integrates the national cultural spirit and global vision. The main body is composed of five single-petal hibiscus, strictly following the form standards of national flowers, symbolizing the five spiritual cores of "openness, unity, inheritance, co-prosperity and innovation" of the Hainan Township Group.

Each petal is cleverly integrated into the four colors of the Malaysian flag – blue, yellow, white and red: blue implies the diverse and inclusive Hainan culture, yellow pays tribute to the tradition of Hainan people's diligent struggle, white symbolizes the pure original intention of cultural inheritance, and red condenses the blood-related hometown ties. Green for vitality, and the single golden stamen in the center echoes the spirit of "connected roots and endless life".

In order to highlight the friendship of Hainan around the world, the conference specially prepared a limited edition of 23 countries and specially integrated into the logo memory set of various countries. With flowers as the medium and colors as words, the world's overseas Hainan compatriots are condensed into eternal memories in the global footprints, and conveying the profound meaning of "one flower and five petals are connected to the four seas, and the love of the world is the same heart".

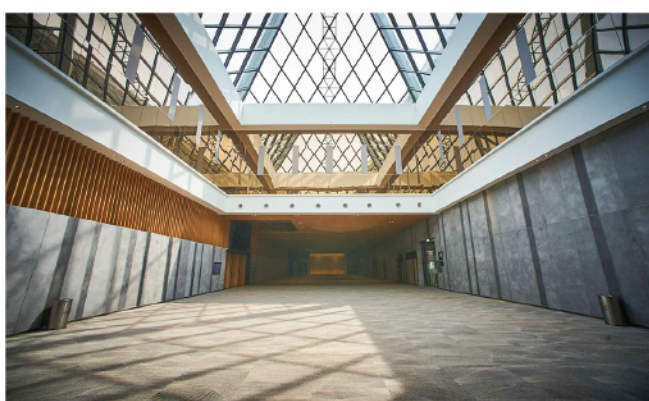

主会场介绍 | Venue Introduction



SETIA SPICE国际会展中心由五大设施组成，其中包括顶楼花园、国际会展中心、一座国际体育竞技场、五星级酒店、停车场和水上运动中心。其中室内竞技场是巴生谷外最大的综合室内体育馆，并设有1万个固定座位和3千个可伸缩座位。该竞技场可容纳一个3000名的坐席宴会和140个标准展览柜台。该竞技场部分位于地面，同时位于体育馆2层。水上运动中心上方也有装置太阳能板，为场馆提供电源。这里也曾是马来西亚运动会和东南亚运动会的举办场所之一。而且从槟城国际机场出发到SETIA SPICE 国际会展中心距离仅有 4.4公里。

The SETIA SPICE International Convention and Exhibition Centre consists of five major facilities, including a rooftop garden, an international convention and exhibition centre, an international sports arena, a five-star hotel, a parking facility, and a water sports center. Among them, the indoor arena is the largest comprehensive indoor sports stadium outside the Klang Valley, with 10,000 fixed seats and 3,000 retractable seats. The arena can accommodate a 3,000-seat banquet and 140 standard exhibition booths. The arena is partly located on the ground floor and also on the second floor of the sports complex. Above the water sports center, there are solar panels installed to provide power to the venue. This venue has also served as one of the locations for the Malaysia Games (Sukma) and the Southeast Asian Games. Additionally, the SETIA SPICE International Convention and Exhibition Centre is only 4.4 kilometers away from Penang International Airport.

PCCC In Brief

Established in 1903, the Penang Chinese Chamber of Commerce (PCCC) was one of the, if not the pioneer trade organization founded at the turn of the twentieth century in this region. It has come a long way since its humble inception and is now one of the strongest commercial institutions in Malaysia in terms of membership and organizational and functional characteristic that is well recognized by both the public and private sectors. In year 2003, the Registrar of Society of Malaysia (ROS) presented the Award Certificate of Excellent Society to the Chamber. It has also been awarded the ISO 9001:2000 Quality Management System (QMS) Certificate in March 2006 and upgraded to ISO 9001:2008 QMS in March 2010.

The objectives of the Chamber as promulgated in its Rules & Constitution are as followsto improve and develop trade and industry;

- a. to collect, collate and disseminate commercial information and to issue certificates of authentication;
- b. to arbitrate and settle trade and industrial disputes;
- c. to collect and compile trade statistics;
- d. to organize trade exhibitions, seminars and human resource development programmes either on its own or in collaboration with other institution(s);
- e. to support charitable, cultural and educational institutions.

The Chamber now has more than a thousand membership composed of individuals, corporations as well as commercial associations and trade guilds. The members of PCCC are from various business sectors, including enterprises, financial institutions, listed companies, housing & construction, garment & textiles, sole-agents & retailers etc.

Policy formulation and decision making at the highest level of PCCC are vested in a 51-member General Committee headed by a President assisted by a Deputy President and 3 Vice-Presidents. A 14-member Executive Committee elected from the ranks of the General Committee meet regularly to supervise the implementation of the policies and strategies formulated and planned by the latter while a permanent Secretariat takes charge of the day-to-day running of the Chamber's affairs.

There are 9 Working Committees and 3 Ad-Hoc Committees charged with various specific functional topics such as business development, small and medium enterprises & human resources development, economics, finance & taxation, housing & construction, infrastructure & public facilities, information technology, transport, logistics & customs, ASEAN-FTA business development, young entrepreneur section and etc. all geared towards complementing the Chamber's important role as a conduit for the exchange of views and information between the Authorities and business community and in promoting the interest of its members in particular and the economic well-being of the country in general.

海南国际仲裁院是海南省政府在原海南仲裁委员会基础上改制设立的国际商事仲裁机构，是省委、省政府贯彻落实习近平总书记“4.13”重要讲话和中央12号文件精神，为营造海南自贸港法治化、国际化、便利化营商环境作出的重要改革举措。

改制后的海南国际仲裁院建立理事会主导的法人治理结构，作为社会公益性法定机构和 nonprofit 法人独立运作，实行决策、执行、监督相互制衡的治理机制，仲裁改革走在全国前列，能够为海南自由贸易港建设提高优质高效的仲裁法律保障。

近年来，海南国际仲裁院坚持法治方向，借鉴国际经验，把握市场规律，扩大国际化规模，加强专业化管理，促进正规化建设，推动现代化发展。组建了由国际知名专家组成的第一届理事会，外籍人士占1/3，理事会的权威性、国际性位列全国前列。提升改造、全面优化仲裁员队伍结构，聘有千余名仲裁员，境外仲裁员占近三分之一，分布全球40个国家和地区，实现主要法域全覆盖，储备了高端涉外法治人才。吸收国际先进仲裁制度，制定海南国际仲裁院章程、理事会议事规则、调解规则、仲裁员报酬支付办法、机构设置和用人规模方案、工作人员聘用条件及职级薪酬规定等十多项基础性文件。全面修订仲裁规则、仲裁员管理办法、仲裁员办案操作规程、案件审理流程管理办法、仲裁结案文书制作规定、仲裁案件费用管理规定等规章制度。经过持续制度集成创新，实现了决策机构、治理机制、仲裁规则、仲裁员队伍、调解机制和执行机构“六个国际化”，以及党建工作、仲裁公信力、仲裁服务管理能力、社会知晓度、服务保障能力和国内国际交流合作“六大提高”。

2020年6月1日，设立国际商事调解中心，建立调解员队伍，面向境内外开展业务，受理平等主体的自然人、法人、非法人组织之间的商事争议，包括合同纠纷和其他财产权益纠纷等。调解中心对标境内外知名调解、仲裁机构先进理念制定调解规则，充分尊重当事人调解意愿，以方便当事人为出发点，简化程序，灵活高效。同时，调解中心积极与人民法院等单位建立诉讼、仲裁和调解工作协作机制，与境内外国际商事调解机构开展合作，建立友好联系，学习和借鉴境内外国际商事调解机构的先进做法和有益经验，健全和完善工作机制，为当事人提供“仲裁+调解”双轨运行并有效衔接的纠纷解决法律服务。

海南仲裁改革的有益探索和实践，对外提升了仲裁公信力和影响力，对内推动了仲裁制度的改革创新，成为海南自由贸易港法治建设的重要窗口。海南国际仲裁院将认真贯彻落实习近平总书记“把非诉讼纠纷解决机制挺在前面”的重要指示，紧紧抓住“中国特色自由贸易港”战略机遇，瞄准建设面向东南亚辐射太平洋服务自贸港的国际一流仲裁机构目标，勇于创新，敢于担当，持续深化仲裁制度创新，不断提高仲裁裁决质效和仲裁员办案水平，全面提升仲裁公信力，高质量推进国际商事仲裁中心建设，奋力开创海南仲裁事业新局面。

Hainan International Arbitration Court (HIAC) is an international commercial arbitration institution established by the People's Government of Hainan Province on the basis of the former Hainan Arbitration Commission. It is an important reform measure made by the Provincial Party Committee and the Provincial Government to create a rule-of-law, internationalized and convenient business environment for the Hainan Free Trade Port (FTP) by implementing the important 4.13 speech of General Secretary Xi Jinping and the spirit of Document No. 12 of the Central Committee of the CPC.

The reformed HIAC has established a corporate governance structure led by the Board of Directors. It operates independently as a public welfare statutory institution and a non-profit legal person, and adopts a governance mechanism in which decision-making, execution and supervision are checked and balanced. It has taken the lead in the reform of arbitration nationwide, and is able to provide a legal guarantee for high-quality and efficient arbitration for the construction of the Hainan FTP.

In recent years, HIAC has adhered to the direction of the rule of law, learned international experience, grasped market rules, expanded the scale of internationalization, strengthened professional management, promoted standardized construction, and pushed forward the development of modernization. The first Board of Directors has been consisted of internationally renowned experts, one third of which are foreigners. The Board of Director's authority and internationalization are among the top national-wide. Great efforts have been made to upgrade and comprehensively optimize the panel of arbitrators. More than 1,000 arbitrators have been empaneled, nearly one third of which are overseas arbitrators, and they are located in 38 countries and regions around the world, covering all the main jurisdictions and reserving high-end foreign-related rule of law talent. We have adopted advanced international arbitration systems and formulated more than 10 basic documents of HIAC, such as the Articles of Association, Rules of Procedure of the Board of Directors, Mediation Rules, Measures for Payment of Remuneration of Arbitrators, Organizational Structure and Post Setting Planning, Post Qualification for Employment and Remuneration scheme of Staff. We have comprehensively revised rules and regulations such as Arbitration Rules, Administrative Measures for Arbitrators, and Operating Procedures for Arbitrators for Case Handling, Administrative Measures for Case Trial Process, Regulations on the Production of Arbitration Closing Documents, and Regulations on the Management of Arbitration Case Expenses, etc. Through the continuous system integration and innovation, it has achieved the "six internationalizations" of the decision-making body, executive body, arbitration rules, arbitrator structure, arbitration secretary team and governance mechanism, as well as "five major enhancements" of the ability to resolve non-litigation disputes, arbitration credibility, social awareness, international influence and Party building.

On June 1, 2020, HIAC set up International Mediation Centre and established a panel of mediators to conduct domestic and overseas business and to accept and handle commercial disputes between natural persons, legal persons and unincorporated organizations with equal subjects, including contract disputes and other disputes over property rights and interests. The Mediation Center has formulated mediation rules according to the advanced concepts of well-known mediation and arbitration institutions at home and abroad, fully respect the mediation willingness of the parties concerned, simplify the procedures, and be flexible and efficient for the convenience of the parties concerned. Meanwhile, the Mediation Center actively establishes a coordination mechanism for litigation, arbitration and mediation work with the People's Court and other entities, cooperates with international commercial mediation institutions both at home and abroad, establishes friendly contacts, learns and uses for reference the advanced practices and useful experiences of international commercial mediation institutions both at home and abroad, improves and perfects the working mechanism, and provides the parties with legal services for dispute resolution under the dual-track operation and effective connection of "arbitration + mediation".

HIAC will conscientiously implement the important instruction of General Secretary Xi Jinping of "putting forward the non-litigation dispute resolution mechanism", and in accordance with the requirements of the Overall Plan for the Construction of the Hainan FTP, firmly seize the strategic opportunity of "Chinese Characteristics FTP", aim at the goal of building a first-class international arbitration institution for Services Southeast Asia and the Pacific Radiation Zone, have the courage to innovate and assume responsibilities, establish and improve a diversified dispute resolution mechanism, continuously improve the quality and efficiency of arbitration awards and the proficiency of arbitrators in handling cases, and comprehensively enhance the credibility of arbitration, and strive to create a new situation for Hainan Arbitration.
